# BUSINESS SUPPORT ANNOUNCEMENTS AND UPDATED GUIDANCE

## FURLOUGH SCHEME EXTENDED TO OCTOBER

On Monday, the Chancellor Rishi Sunak announced a four month extension to the Job Retention Scheme. The scheme will continue in its current form – where workers will receive 80% of their current salary up to £2,500 – until the end of July. From August furloughed staff will be able to return to work part-time with businesses being asked to pay a percentage towards their salary. More specific details and information around its implementation will be made available by the end of this month. The extension is available for all businesses and industries.

## SELF-EMPLOYMENT INCOME SUPPORT SCHEME GOES LIVE

Yesterday applications opened for the government's Self-Employment Income Scheme, designed to support those who are self-employed whose income has been impacted by the crisis. Payments will be paid in single instalments over a three month period and capped at £7,500. All eligible individuals who applied yesterday should receive payment by 25 May, or within six days of a completed claim.

#### GOVERNMENT LAUNCHES FIVE ROADMAP TASKFORCES

Yesterday, the Government announced the establishment of five new ministerial led taskforces, set up to develop plans for how and when closed sectors including pubs and restaurants, non-essential retail and recreation and leisure can re-open safely, this follows the launch of the government's 50 page **roadmap to rebuild Britain** strategy on Monday. Each taskforce will lead on developing new COVID-19 secure guidelines for reopening. Details have yet to be announced around timings for when the guidelines will be made public and ready for businesses to start to implement.

#### GOVERNMENT STEPS IN TO TEMPORARILY GUARANTEE TRADE CREDIT INSURANCE AGREEMENTS

The Economics Secretary to the Treasury, John Glen, confirmed on Thursday that the government would temporarily guarantee all B2B transactions currently supported by Trade Credit Insurance in order to support those businesses who are unable to cover bills due to the crisis. Guarantees will provisionally run to the end of 2020, the government will then conduct a full review of the TCI market to ensure it can continue to support businesses in the future. Further details will be announced in the coming weeks.

#### TRANSPORT INFRASTRUCTURE TRANSFORMATION

At the end of last week, the Transport Secretary, Grant Shapps announced a £2 billion package to create a new infrastructure scheme for London that is being called a 'new era for cycling and walking'. This is a part of the £5 billion in new funding announced for cycling and buses back in February. The project will be funded by the government but delivered by local authorities.

## KINGSTON COUNCIL UPDATES

### MOBILE CORONAVIRUS TESTING UNIT IN CATTLE MARKET CAR PARK

On Friday 15 and Saturday 16 May a Mobile Testing Unit will be set up in the Cattle Market Car Park as part of the government's national testing programme.

Please note this is not a walk-in unit and all testing appointments have to be booked in advance through the **Government's national self referral portal.** Bookings are only available for those identified as eligible – essential workers and members of their household who have symptoms, all over 65s with symptoms and all care home staff.

#### **TOP-UP GRANTS**

The government has announced plans for <u>further grants</u> for small businesses with ongoing propertyrelated costs and COVID-19-related falls in income.

Guidance from government to Councils was only announced late this week, therefore recipients and criteria for this funding is yet to be established. At this stage, no action is required from businesses on this new fund. We will keep you updated.
