BUSINESS SUPPORT ANNOUNCEMENTS AND UPDATED GUIDANCE

CORONAVIRUS STATUTORY SICK PAY REBATE SCHEME TO LAUNCH

On Tuesday, the government announced that from 26 May small and medium size employers, with less than 250 employees, will have access to a new online service to recover Statutory Sick Pay [SSP] payments. Businesses will be able to receive repayments that have been paid to current or former employees from the 13 March 2020. The repayment will cover up to 2 weeks of SSP. It is important to note that in order to claim employers should keep records of all the SSP payments they would like to claim.

HOUSING MARKET RE-OPENS

Last week the Housing Secretary Robert Jenrick confirmed that Estate Agents could officially re-open in order to kick start the housing market. Agents are being advised to consider how and when to reopen their premises given government guidance on safer working. Strict government led guidelines have been put in place on how viewings and housing moving operations can be managed safely during the pandemic.

RADICAL TRANSFORMATION OF LONDON'S STREETS

Transport for London this week released 'The London Streetscape' programme. Developed in response to the governments easing of the lockdown restrictions the plan looks at how London streets will be radically transformed to accommodate the increase in cycling and walking. TfL are working with local boroughs across London at how plans such as widening pavements and creating new temporary cycle networks can be implemented across the capital.

DRAFT RE-OPENING GUIDELINES FOR PUBS AND RESTAURANTS ANNOUNCED
